

SETTLEMENT REPORT FOR JUNE 11, 2025 MEETING

The Treasurer received a payment of \$4,037,405.00 on April 15, 2025. This amount represents the 2025 payment from Walgreens under the terms of the national settlement. The Treasurer also received a payment of \$173,307.80 on April 29, 2025. This amount represents a payment from Mallinckrodt for reimbursement for the State's litigation costs under the terms of an approved bankruptcy plan.

Pursuant to the terms of the agreement between the State of South Carolina and its participating political subdivisions, money shall be allocated as follows:
