SETTLEMENT REPORT FOR SEPTEMBER 10, 2025 MEETING

The Treasurer received a payment of \$34,415,291.59 on August 8, 2025. This amount represents the 2025 payment from the Distributors, Allergan, CVS, and Teva under the terms of the national settlements. The Treasurer also received a payment of \$45,732.82 on August 15, 2025. This amount represents a payment from Walmart for reimbursement for the State's litigation costs under the terms of the national settlement.
