

## SETTLEMENT REPORT FOR SEPTEMBER 22, 2023 MEETING

The Treasurer received a payment of \$13,190,226.89 on August 2, 2023. This amount represents the 2023 payment from the Distributors under the national settlement.

An amended opioid allocation agreement has been executed. Consequently, \$646,611.50 held in the Opioid Recovery Fund has been transferred to the Administrative Subfund, and \$443,915.37 has been transferred to the Guaranteed Political Subdivision Subfund for use by MUSC. In addition, \$188,180.44 from the Mallinckrodt settlement is being transferred from the Opioid Fee Fund to the Opioid Recovery Subfund. All interest in the Opioid Recovery Fund has been transferred to the Discretionary Subfund.

Pursuant to the terms of the agreement between the State of South Carolina and its participating political subdivisions, money shall be allocated as follows:
